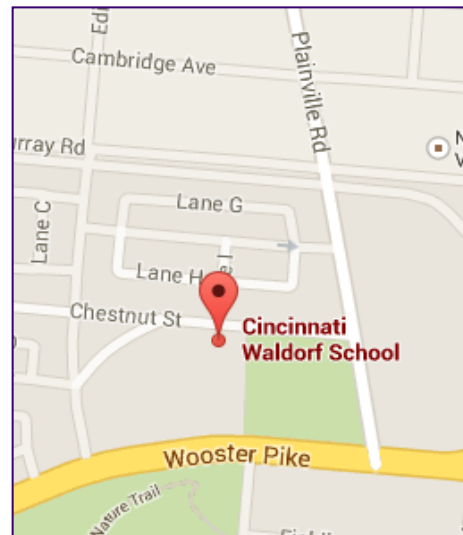

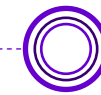

HIGHLAND DANCING RULES

- ◇ The competition will be conducted following S.O.B.H.D. rules. The judge's decision is final.
- ◇ The first dancers to enter shall be last to dance.
- ◇ Dancers must be in costume to accept awards.
- ◇ Competitors not ready when their event is called will be disqualified for that dance.
- ◇ The number of entries will determine age groupings.
- ◇ Dancers must present 2017 valid registration card.
- ◇ A trophy will be awarded to the highest point winner in each age group. No trophy will be awarded to the primary level. Medals will be awarded at the judge's discretion.
