1. Competition governed by SOBHD rules. FUSTA ID USW0601.
2. For Beginner and Novice dancers the two days of competition is considered one competition. Aggregate trophy will be awarded at the end of dancing on Sunday.
3. Trophy Fling for Beginner and Novice dancers does not count toward aggregate points. Special Intermediate hornpipe does not count toward aggregate points.
4. Change of status must be phoned or emailed to Flora Schupp 717-253-0266 / [fschupp59@gmail.com](mailto:fschupp59@gmail.com) by April 5, 2017.
5. Age is as of April 8, 2017.
6. All competitors must include their FUSTA/ScotDance or SOBHD affiliate number on the entry form and must present their registration card to receive prizes.
7. Only one entrant per entry form.
8. Classes may be combined or split at the discretion of the dancing committee. All classes to be split at the close of entries.
9. First entered will be last to dance. Competitors not present when scheduled or causing delay will forfeit entry in the event.
10. Any attempt to approach a judge or dance piper by any competitor or their parent may result in disqualification.
11. The decisions of the judges are final. Protests must be made in writing and in the hands of the Games Executive Secretary along with a \$25.00 fee prior to the end of the day's competition. If the protest is sustained, the fee will be returned.
12. It is the responsibility of the competitor to pick up all awards at the Competition. Failure to do so will result in forfeiture of all awards.
13. Mail entries to Flora Schupp, 46-302 Kahuhipa St, Kaneohe, HI 96744 USA.
14. Entries open January 1, 2017 and close March 1, 2017. Late entries & field entries accepted at double the entry fee.
15. Fees must accompany application and entry form. NO REFUNDS.
16. Payment will only be accepted in U.S. Dollars in the form of a money order or bank draft made payable to The Hawaiian Scottish Association.
17. Choreography rules as per SOBHD. Group choreographies may consist of pre-premier and premier dancers. Solo choreographies will be split into pre-premier and premier. Pre-premier dancers do not receive stamps for choreographed events.
18. Group Choreography entry form and fees may be mailed with any one dancer in the group.
19. Solo Choreography time limit of 3 minutes. Group Choreography time limit of 3 minutes.
20. Choreography music must be on a CD and labeled with dancer or group name. or on a phone/ipod that will connect to the system with an audio cord.
