2. Age groups will be determined according to the number of entries. All competitors' ages determined as of the day of the competition May 18, 2019.
3. 2019 FUSTA/ScotDance card must be presented at time of registration.
4. Dancers entering first will dance last. Dancers must be ready and appear when called or forfeit the chance to dance in that event.
5. Medals will be awarded in each event. DANCERS MUST BE IN COSTUME TO RECEIVE AWARDS. If there are three dancers or less in any event, medals will be awarded at the judges discretion.
6. No aggregate for primary.
7. In case of a tie for the aggregate points, overall winner will be determined by a dance-off.
8. The organizer reserves the right to modify the schedule.
9. Entries close May 10, 2019.
