Rules & Regulations Governing the Competition

- The competition is run and conducted according to SOBHD rules.
- First to enter, last to dance.
- All judge's decisions are final.
- All dancers must report when called or will forfeit entry in that event.
- Dancers must show their 2019 registration card in order to receive awards.
- All dancers competing without a 2019 registration card must show his/her card to the organizer within 10 days of the event, and all names will be given to the FUSTA National Registrar. A fee of \$10 will be required.
- Proof of age must be provided if requested.
- Trophies will be awarded in each category (except Primary) and will be based on overall aggregate points. Medals will be awarded in all Pre-Premier categories. Cash prizes will be awarded for at least 3 oldest Premier age groups.
- Age groups will be determined by organizers based on entries received.
- Most Promising Beginner & Novice awards will be presented and is the judge's decision.
- Dance-of-the-Day Award: Optional entry for all premier dancers, with no age group designations.
