- 2. Dance entries will not be accepted without a FUSTA /Scotdance registration number
- 3. Dancers must have their FUSTA /Scotdance card to pick up awards
- 4. Entries must be postmarked by June 1, 2019. Double entry fees apply after May 15, 2019.
- 5. Field entries may be accepted at the discretion of the Dance Committee, double entry fees apply
- 6. Class breakdown will be determined by the dance committee when all entries have been received
- 7. Decision of the judge is final. Any protest must be made in writing and handed to the Dance Committee with \$25 fee, nonrefundable.
- 8. Dancers must dance to the piper provided
- 9. Any dancer not ready when called, shall forfeit entry in that event
- 10. Good sportsmanship is required of all competitors, parents and spectators.
- 11. Highland and National dance points will be combined to calculate the aggregate trophy winner.
